Guest Information

Guest Full Name

Complete legal name as shown on identification

Check-In Date

Exact arrival date for stay duration calculation

Check-Out Date

Departure date to determine total taxable nights

Essential for accurate recordkeeping and tax audits.

Room & Booking Details

Room Rate

Base nightly rate before taxes and fees

Booking Type

Direct, online platform, or travel agent reservation

Exemption Applied

Permanent resident or qualified camp exemptions

Documentation

Proof of exemption status and signed agreements

NJ Sales Tax

Standard rate of 6.625% applies to room charges

State Occupancy Fee

Up to 5% additional state-mandated lodging fee

Municipal Tax

City or local lodging tax varies by location

Track separate lines for each required tax to ensure proper filing.

Total Collected

Room rate plus all applicable taxes combined

Remittance Date

When taxes are paid to tax authorities

Accuracy Check

Sum accurate totals to avoid underpayment errors

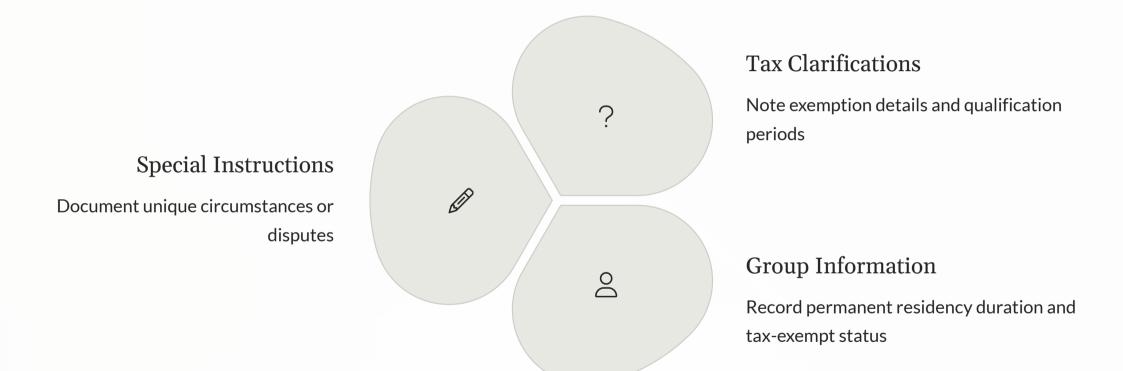
